

# MSME UDHYAM REGISTRATION (W.E.F. JULY 01, 2020)



### **New Classification Criteria**



Classification	Micro	Small	Medium
Investment in Plant & Machinery or Equipment	< Rs. 1 crores	< Rs. 10 crores	< Rs. 50 crores
Turnover	< Rs.5 crores	< Rs. 50 crores	< Rs. 250 crores

### REGISTRATION PROCEDURE



File online registration for in Udyam Registration Portal On registration, a permanent identity number will be assigned

e-Certificate (Udyam Registration Certificate) shall be issued

(based on self-declaration with no requirement to upload documents, papers, certificates or proof)

#### **CRITERIA FOR CLASSIFICATION**

Criteria of **INVESTMENT & TURNOVER** shall **JOINTLY** apply for classification as micro, small or medium

What if any enterprise has satisfied either of 2 criteria

- If crosses the ceiling limits specified for its present category in either of the 2 criteria, will cease to exist in that category and be placed in the next higher category
- Similarly, No enterprise shall be placed in the lower category, unless it goes below the ceiling limits specified for its present category in both the criteria



### **PAN WISE TURNOVER & INVESTMENT**



All GSTIN listed against same PAN shall be COLLECTIVELY TREATED as one enterprise.



The Investment and T/O of such units are aggregated and considered for deciding the category as micro, small or medium enterprise

# CALCULATION OF INVESTMENT IN PLANT & MACHINERY / EQUIPMENT

**UPDATEDESK** 

Investment linked to the ITR of the previous years filed under the Income Tax Act, 1961

If no ITR available, based on self-declaration. Such relaxation upto March 31 when 1st ITR filed

Meaning of "plant & machinery / equipment" as assigned in the Income Tax Rules, 1962

Consider invoice value excl. GST

Cost of certain items specified in Explanation I to section 7(c) of the MSME Act, 2006 (such as Cost of pollution control equipment, R&D, etc.) to be excluded



### **CALCULATION OF TURNOVER**



**Exports** of goods or/and services to be excluded

Turnover & Exports shall be linked to the Income Tax Act or the CGST Act & the GSTIN



Where PAN not available, Turnover will be considered on self-declaration basis upto Mar. 31, 2021 & thereafter, PAN & GSTIN mandatory

### REGISTRATION OF EXISTING ENTERPRISE



All existing registered under EM-Part-II / UAM shall register again on Udyam Registration portal on or after July 1, 2020



All enterprises registered till June 30, 2020, shall be reclassified in accordance with this notification

The existing registered prior to June 30, 2020 shall continue to be valid only for period up to March 31, 2021



An enterprise registered with any other org. under the Ministry of MSME shall register under Udyam Registration

UPDATION OF INFORMATION

In upward change, enterprise will maintain its prevailing status till expiry of 1 year from

close of the registration year

Based on the info. furnished / gathered from Govt. sources incl. ITR / GST return, the classification will be updated

In downward change, enterprise will continue in present category till closure of FY & will move in new category in subsequent FY

## FACILITATION & GRIEVANCE REDRESSAL OF ENTERPRISES



- Champions Control Rooms = Single Window Systems (SWS) for facilitating registration process & handholding MSMEs
- District Industries Center's (DICs) = SWS in their districts
- Person not able to file Udyam Registration for any reason may approach SWS with <u>Aadhaar enrolment identity slip / copy of Aadhaar enrolment request / bank photo</u> <u>pass book / voter identity card / passport / driving license</u>
- In case of any discrepancy / complaint, Gen. Mgr. of (DICs) shall undertake an enquiry &
  forward the matter to Director / Commissioner / Industry Secretary, who will issue
  notice to enterprise & give them opportunity to present case and based on the findings,
  may amend / recommend to Ministry of GOI for cancellation of Udyam Registration
  Certificate
